**The following are terms and restrictions of this self-exclusion and are enforced by all Creek Nation Casino's and the Office of Public Gaming, Muscogee Nation IT: (please initial each of the following statements)**

- \_\_\_\_\_ This exclusion is valid for all nine (9) Muscogee (Creek) Nation Gaming Facilities including two (2) Travel Plazas within Oklahoma and services associated with Muscogee (Creek) Nation Facilities.
- \_\_\_\_\_ I will not attempt to enter and/or use any of the services or privileges of the gaming facilities from which I have requested exclusion during the period of the self-exclusion.

- \_\_\_\_\_ I understand that should I enter a Muscogee (Creek) Nation, Gaming Facility or use the services of the facility that once identified; I shall be promptly escorted from the facility.
- \_\_\_\_\_ This self-exclusion request is irrevocable for two (2) years.
  - Upon request to have a self-exclusion lifted the request must include a letter requesting a hearing before the Executive Director of the Gaming Commission.
  - If the Executive Director approves the request, the Director shall inform all gaming operations of the removal no later than 10 days after approval. If the Executive Director denies the request, they shall send to the person who had requested the removal a Notice of Denial of Removal from the Self-Exclusion List by certified mail.
- \_\_\_\_\_ The Office of Public Gaming will treat this self-exclusion request confidentially. “No gaming operation may disclose the name of any person on the Self-Exclusion List to any third party unless specifically authorized by this Part or required by a court order.”
- \_\_\_\_\_ I understand that the Office of Public Gaming shall require the gaming facilities to remove my address from all mailing lists and to revoke any player’s cards.
- \_\_\_\_\_ I understand that the Office of Public Gaming shall prohibit the Muscogee (Creek) Nation Gaming Facility Personnel from paying any jackpot, tickets, or chips to a person who is on the Tribal self-exclusion list. The Policy states the person agrees to “forfeit all jackpots, chips or tokens in play or in plain view, Non-complimentary Pay Vouchers, and electronic credits in his or her possession or control.” The funds will be donated to a registered non-profit organization that assists individuals with problem gambling.
- \_\_\_\_\_ I understand that neither the Tribe, Gaming Facility Personnel, Gaming Commission Office, nor any employee thereof shall be liable to any self-excluded person or to any other party in any proceeding and neither the Tribe, Gaming Facility Personnel, nor the Gaming Commission Office shall be deemed to have waived its sovereign immunity with respect to any person for any harm, monetary or otherwise, which may arise as a result of:
  1. The failure of Gaming Facility Personnel or Gaming Commission Office to withhold gaming privileges from or to a self-excluded person; or
  2. Otherwise permitting a self-excluded person to engage in gaming activity in a gaming facility while on the list of self-excluded persons.
- \_\_\_\_\_ I will not seek to hold the Muscogee (Creek) Nation of Oklahoma or Muscogee (Creek) Gaming Facility and/or use any of the services or privileges therein despite this exclusion request, and I agree to indemnify the Muscogee (Creek) Nation of Oklahoma for any liability relating to this request.
- \_\_\_\_\_ Failure to provide any information or to execute any forms deemed necessary by the Executive Director may result in a denial of a request for placement on the Self-Exclusion List. (Such forms may include a request to waive liability of the Office of Public Gaming, the Executive Director, its agents and the Muscogee (Creek) Nation for any damages that may arise out of any act or omission related to placement of the Self-Exclusion list.

Both Gamblers Anonymous and Gam-Anon programs are self-help groups that promote change and personal growth, usually in regards to addiction and other personal issues.

If an applicant wishes to Self-Ban him/her self from the Muscogee (Creek) Nation Gaming facilities, the option is his/hers.
